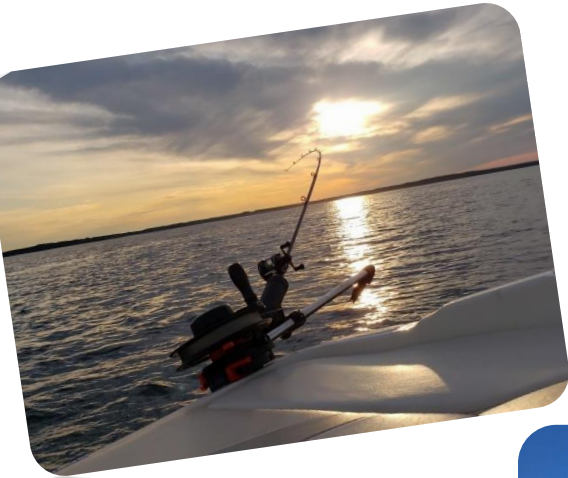

2. Photo entries must be taken by the individual submitting them.
3. Individuals may submit up to two (2) photographs per category.
4. Photographs must be submitted to a specific category.
Photographs not submitted to a specific category will be disqualified.
5. Individuals may submit entries to more than one (1) category.
6. No captions.
7. Photo editing is permitted. The editing should be used in moderation to clarify image and remove minor imperfections. Excessively edited images, for example sepia, may be disqualified.
8. All photographs must be submitted in JPEG format on a USB or CD. No email please.
