- Phase one: Any company that meets the 40 per cent threshold will be able to apply for the grant by end of day November 24.
- Phase two: Companies that wish to apply for a second round of funding will be able to do so within the coming weeks. More detailed information on phase two timing will be available this week.

Canada Emergency Rent Subsidy applications now open.

To support Canadian businesses, the Canada Emergency Rent Subsidy is able to support up to 65% of eligible expenses to tenants and property owners for qualifying organizations affected by COVID-19.

Currently you can only apply for October. November will be open for application December 1.

Support for businesses, non-profits, and charities

A wide range of organizations can apply directly to the CRA for support:



Sole proprietorships and taxable corporations



Partnerships consisting of 50% or more eligible organizations



Certain Indigenous government-owned corporations



Registered charities



Non-profit organizations



Accessible Base Subsidy

All eligible organizations that have experienced a revenue drop* can qualify for a base rent subsidy of up to 65% of eligible expenses. Your subsidy amount is based on your revenue drop.



Lockdown Support

Organizations that have to close their doors or face significant restrictions because of public health lockdowns can qualify for additional Lockdown Support of 25% for each affected location.



Wide range of eligible expenses

**Organizations can claim any of the following (minus any subleasing revenues):



commercial rent



property taxes (including school taxes and municipal taxes)



property insurance



interest on commercial mortgages

** subject to limits



Flexibility
