# Province Wide.....

## Alberta honours veterans with new motorcycle plate

*Calgary...* Starting next spring, Albertans who served their country in the forces will be able to display veterans' licence plates on their motorcycles with the expansion of the provincial government's veterans' plate program.

"Albertans respect the sacrifice of the men and women in the Canadian Forces, and the veterans' licence plate is an instantly recognizable reminder of that sacrifice," said Service Alberta Minister Manmeet Bhullar. "We owe a lot to veterans for the freedoms and rights we enjoy today and the provincial government is happy to provide yet another way of showing our appreciation for all veterans have done."

Nearly 21,000 veterans' plates have been issued since the program began in February 2005. Plates are available to retired forces members who have been honourably discharged, as well as members of the Royal Canadian Mounted Police or other Canadian police departments who served under NATO or the United Nations.

Last year, the Alberta government, working with the Royal Canadian Legion Alberta-Northwest Territories Command, expanded eligibility to include currently serving Canadian Forces members with at least three years of service.

"Alberta veterans and current forces members are proud of their service to their country," said Darrel Jones, president of the Royal Canadian Legion Alberta-N.W.T. Command. "They appreciate the recognition from Albertans for their contribution and they will be proud to display the new motorcycle veterans' licence plate."

Alberta will be the third province to offer veterans' motorcycle plates when they become available in April 2012.



## *A message from the Executive Director*

*With the holiday season fast approaching, our lives seem to get even more hectic than usual. A large part of this is the stress of finding those perfect gifts. Now we are faced with the decisions concerning specifically where we are going to make those purchases. Hopefully you've taken into consideration shopping right here in Cold Lake and have based that decision on the fact that you'd like to keep your dollars in our local community. After all, it's just as easy to spend that money somewhere else, right? Consider this, each dollar spent locally circulates between 6 and fifteen times, for example a dollar spent in a retail store could be used by the store owner to pay rent to a landlord, who then might use that dollar to buy gas. The gas station owner then uses the dollar to buy something at the hardware store, and the hardware store owner may use the dollar to buy something at the pharmacy and so on. Once that dollar is taken outside of our city, that multiplier effect dissolves. Local businesses are usually owned by fellow community members, friends and neighbors who also contribute to the community in tangible and intangible ways. For instance, they are usually the ones supporting the communities' latest fundraisers for hockey teams, dance and gymnastic groups or even the betterment of our healthcare through programs such as Hearts for Healthcare just to name a few. If we don't support local business, it is unlikely they could support community organizations.*

*Shopping locally creates a healthy retail sector and this is attractive to new industry. Without it, we don't stand much of a chance of attracting new businesses. Empty store fronts are a sign of a weak retail sector and not very attractive for economic growth. Communities with a healthy retail sector tend to attract new business and thereby offering more to its consumers. So as you take these thoughts into consideration please remember to support those who support you either directly or indirectly.*
