- Canada Small Business Financing Programs: makes it easier for small businesses to get loans from financial institutions by sharing the risk with lenders. Up to a maximum of \$1,000,000 for any one borrower, of which no more than \$350,000 can be used for purchasing leasehold improvements or improving leased property and purchasing or improving new or used equipment. Financial institutions deliver the program and are solely responsible for approving the loan.

Alberta Critical Worker Benefit

To support workers who have delivered critical services to Albertans, the province has created the Critical Worker Benefit, which provides a one time payment of \$1,200 to eligible workers to recognize them.

For the private sector, employers must apply on behalf of their eligible employees. To be eligible for the Critical Worker Benefit, private sector workers must:

- earn \$25 per hour or less
- have worked at least 300 hours between the period of October 12, 2020 and January 31, 2021
- be located and working in Alberta
