Budget 2021 Support for Businesses.

In the most recent federal budget delivered on April 19, support for businesses that have been impacted by the ongoing COVID-19 pandemic are continued.

Programs such as the Canada Emergency Wage Subsidy, Canada Emergency Rent Subsidy and Lockdown Support have been extended until September 25, 2021.

In addition to support for businesses, support is also being provided to employees with extending the number of weeks of income support programs such as the Canada Recovery Benefit and the Canada Recovery Caregiving Benefit.
