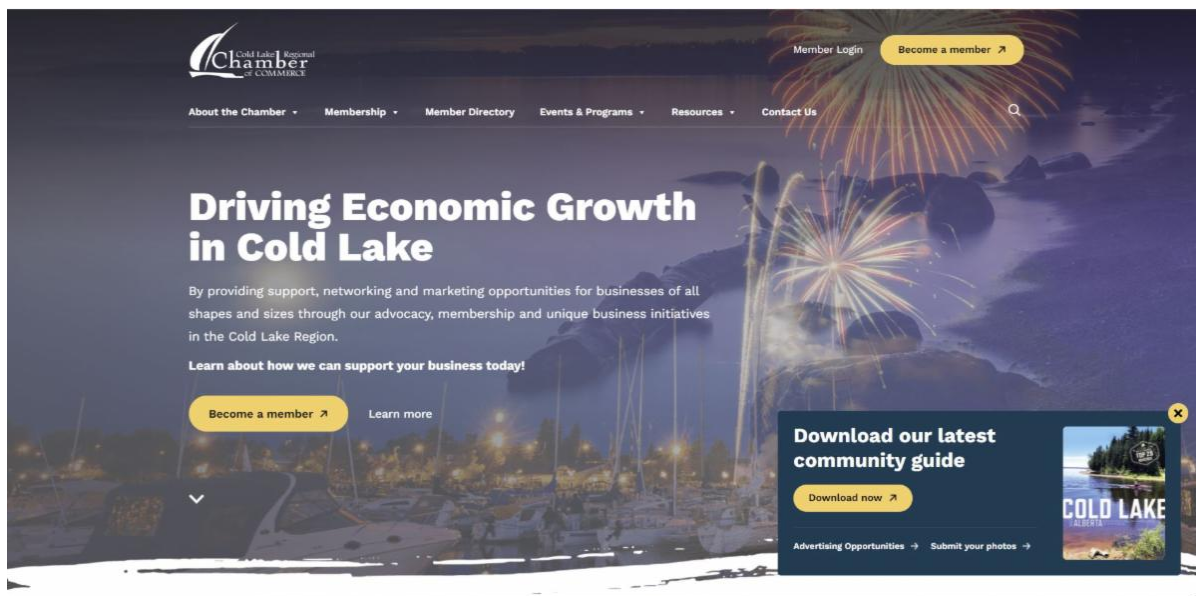

Tourism Levy Abatement for Businesses

For business that are in the tourism industry, the Government of Alberta is providing support to those who have experienced decreases in revenue. Eligible accommodation providers who have experienced a 40 per cent decline in room revenue compared to 2019 will be able to keep tourism levy amounts collected between October 1, 2021 and March 31, 2022.

This measure was introduced to allow dollars to stay in the hands of business owners in the accommodation sector be able to employ staff and stay operational throughout the winter.

Federal Government Support for Businesses

In December 2021, the targeted COVID support measures from the federal government received Royal Assent. One change comes to the Canada Recovery Hiring program where the subsidy amount has been increased from 20 per cent to 50 per cent. 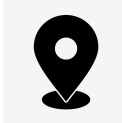
